Marching Band Members and Parents,

The Medina Musical Bees Marching Band and the Stardusters Jazz Ensemble both have the honor of being selected to perform at Disney World in Orlando, Florida. The Marching Band is scheduled to perform on Saturday, March 24, 2018 and the Stardusters are scheduled to perform on Monday, March 26, 2018.

All band members attending the trip will be touring Disney's Magic Kingdom, Hollywood Studios, Epcot, and the Animal Kingdom. We are also very excited to announce our trip will include a day at Universal Studios Florida!! Additionally, the trip will include a performance of Blue Man Group, breakfast at the Hard Rock Café at Universal Studios, Disney's Typhoon Lagoon Water Park, and finally Disney Springs, formally known as Downtown Disney, for fun and shopping. Breakfast will be provided every morning at our hotel and meal tickets are provided for each park.

We will depart from Medina High School at 10:00 AM on Thursday, March 22nd and return the evening of Wednesday, March 28th. Our tour company has provided us an entirely different transportation company from the trip we took in 2015. Our air-conditioned coaches will be provided by Barons Bus for the duration of our trip. We will be staying at the Rosen Centre Hotel with students rooming in groups of 4 per room.

Finally, a trip of this caliber is not possible without parent chaperones. We are looking for approximately 18-24 chaperones to make this trip possible. Parents, a separate email will be sent over the summer that can be filled out. Parents selected to serve as chaperones will be contacted in September.

STEP 1: ALL TRIP PARTICIPANTS MUST REGISTER

- ✓ If you do not have internet access, you must complete and sign the agreement below and mail it with your deposit to the address located at the bottom of the form. All other payments can be made by check or money order and mailed to the address on the bottom of the form.

STEP 2: ONLINE REGISTRATION (Preferred Method) and DEPOSIT

- ✓ Visit www.noteworthytours.com and click on "Individual Billing"
- ✓ Choose the school by the ID Number (indicated above) and click on "Book"
- ✓ Continue to fill out personal information. *PLEASE USE THE EMAIL OF THE PARENT OR GUARDIAN FOR BILLING PURPOSES*
- ✓ If you choose to make a payment by credit card at the time of registration, choose the drop down menu of "Pay Now". Payments are processed via *PayPal* (PayPal account NOT required). PayPal simply processes the transaction.
- ✓ If you choose to make a payment by check, choose the drop down menu of "Pay Later"

PAYMENT POLICY

- **The Balance is due by February 1, 2018.** If your balance has not been received by February 1, 2018, your reservation will be canceled. No refunds will be issued.
- A 3% late charge will be assessed on amounts due after each payment due date.
- A \$45.00 service fee will be charged for returned checks due to insufficient funds.

CANCELLATION POLICY

- All cancellations must be made in writing to Noteworthy Tours. The cancellation date will be determined by the postmark or email date.
